MAYOR'S LETTER

This month I would like to start out by thanking the literally hundreds of you who sent in emails, wrote letters, posted comments, and/or attended the Prince William Board of County Supervisors (BOCS) hearing and vote on the Oaks III rezoning application on January 10. Although we lost the vote 5-3, the outpouring of community sentiment was truly impressive, with the BOCS chamber filled to overflowing, and nearly as many of the town's supporters seated in folding chairs in the lobby watching on screens as in the chamber itself. Occoquan Supervisor Mike May did an outstanding job leading the Board opposition to the rezoning, and his arguments and yours persuaded Woodbridge Supervisor Frank Principi and Coles Supervisor Marty Nohe to vote with us. The Town Council and others will be monitoring the situation closely in an attempt to do whatever we can to mitigate the anticipated storm water and traffic impacts of the Oaks III project as currently designed. In the meantime, please take a moment when you can to thank not only the county supervisors who supported the town, but the many individuals and business leaders from the surrounding community who did so as well.

By now many of you may have noticed some construction work underneath and near the Route 123 Bridge on Mill Street. The Prince William County Service Authority (PWCSA) is replacing the Occoquan Lift Station, which is currently housed in the small brick building near the BB&T ATM machine. PWCSA very carefully coordinated this well in advance with Town Hall, ensuring that no work would be done during the key shopping months of November and December, nor during any of the town's craft shows. They also did extensive outreach with the businesses adjacent to the relevant property. Current work should be completed within 30 days and with minimal disruption. Eventually, the brick building behind the ATM will be removed; the new structure has been designed to match the pattern and look of the bridge.

Finally, I also want to mention that the revised advertising and sign rules for the historic district are likely to be voted upon at the Town Council meeting on February 7. Members of the ARB Task Force and the ARB worked very hard on this update, which is likely to provide both additional flexibility and clarity to our business community.
