MAYOR'S LETTER


I am pleased to announce this month that progress continues on our long quest to convert to park land the decommissioned water treatment plant at the northwestern end of town. As reported in an earlier newsletter, Fairfax Water, Prince William County, and the town have signed a memorandum of agreement regarding the property's future. Last month, the county and the town agreed to a boundary adjustment that will place all of the approximately 1.11 acres of park land within town boundaries. The parties are now negotiating the long-term lease for the site, and Fairfax Water has indicated that they plan to begin removal of the tanks in late 2013, or early 2014.

We have a number of interesting events coming up in August. On Sunday, August 4, the inaugural Tour of the Towns - Tour of Prince William cycling event will pass through Occoguan. Riders on 27. 35, and 100 mile routes will start and finish just outside of town boundaries. Several Occoquan businesses have sponsored the event, and we hope participants will visit town at the event's conclusion, On Thursday, August 8, at 6:30 p.m. at Town Hall, the Occoquan Historical Society will be hosting the next installment in its lecture series. This free lecture will feature archaeologists working on the historic and pre-historic site digs just across the river in old Colchester.

As some of you are aware, in late June Claudia Cruise resigned as Town Manager. We thank her for her years of service and wish her the best. The Town Council has appointed Sheldon Levi Acting Town Manager on an interim basis. Starting this month, Chief Levi will be extending Town Hall's operating hours to 4:00 p.m. Chief Levi has started a brief, regular column with this month's newslet-

Recently, the town Zoning Administrator has rejected several deck applications, which has prompted the Town Council to remind everyone of the rules that apply to construction of decks. A special insert in this month's newsletter addresses the issue. Last, the Electoral Board has requested that the town consider moving its elections from May to November, as some other local jurisdictions recently have done. This would save the town several thousand dollars, make the elections part of the common November election cycle, and result in voting at the Occoquan Elementary School polling location. The Town Council is interested in resident feedback on the issue, and has set up the email account, "survey@occoquan.org" to receive feedback through the end of the month. Virginia Sales Tax Holiday—August 2-4, 2013

During this three-day period, purchases of qualifying school supplies selling for \$20 or less per item, and purchases of qualifying clothing and footwear selling for \$100 or less per item will be exempt from sales tax. Retailers may also choose to absorb the tax on other items during the holiday period, but they are responsible for paying the tax on those items to the Department of Taxation.
