### MAYOR'S LETTER

September's big event in town is the annual Occoquan fall Arts and Crafts Show, scheduled for September 28 and 29, and a great place to do some early Christmas shopping. As most of you are aware, the net revenues from the town's two arts and crafts shows are the primary source of funding for town capital projects, deferred maintenance, and special initiatives, so please encourage friends and family members to patronize the show's vendors.

One special initiative past craft show revenue is scheduled to fund is the implementation of the town's strategic plan. The town chartered and appointed a Strategic Planning Committee in July of 2011, and after approximately 18 months of research, public meetings, and site visits, the Committee issued its report, which has been adopted by the Town Council as a framework for town initiatives over the next 5-10 years. The evolution and successful implementation of the details of the plan will depend significantly on public involvement and support over time, so I encourage everyone to familiarize themselves with the background and details of the plan, which are available on the town web site ([www.occoquan.org](http://www.occoquan.org)), and to involve themselves in those areas that interest them.

Among other things, the Strategic Plan recommends a program of community engagement projects, in which many of the events we have been holding and promoting over the past half dozen years neatly fit. Along those lines, on September 21, a variety of community partners will be working together for the improvement of the town's waterfront. On that day, the 501(c)(3) Prince William Trails and Streams Coalition will be cleaning up and improving the access points of the shoreline behind the Mill House Museum. Patriot Scuba will be sending divers into the water to remove trash and debris below the town's waterline, and providing a "Project Aware" demonstration suitable for families. And Vulcan Materials will be dispatching staff to clean up their dock complex across the river. Activities are scheduled to start at approximately 9:00 a.m. and run into the early afternoon. Keep an eye out for announcements about how you can participate by assisting in the clean up, viewing the "Project Aware" demonstration, or by simply grabbing a box lunch and watching the scuba divers work.

As always, be alert for other events on the horizon, including VFW activities associated with POW/MIA Recognition Day on September 20, and the arrival of some "Warrior Riders" on October 4 – more details on these as they become available.
