MAYOR'S LETTER

I would like to start 2014 by thanking everyone for your kind words and support over the past twelve months. In particular, I would like to thank those who volunteered during the course of the year, whether by assisting with an event, or serving on a formal body like the Planning Commission, ARB, or other committee. Additionally, thank you to those who were able to fill some of your holidays needs with town businesses. Each of these things, as well as your many other types of contributions, help make Occoquan an attractive place to live, work, and visit.

This month the Town will be hosting two of six planned public input sessions on the town's draft strategic plan. The town chartered and appointed a Strategic Planning Committee in July of 2011, and after approximately 18 months of research, public meetings, and site visits, the Committee issued its report, which has been adopted by the Town Council as a framework for potential town initiatives over the next 5-10 years. Determining which proposed initiatives in the plan will be pursued will depend in large measure on input from residents and business owners. Consequently, if you are able to attend any of the sessions, I encourage you to do so. Our first session will be on January 9 at 7:30 p.m. at the Occoquan Pointe/Barrington Point club house. A second session will be held on January 17 at 9:00 a.m. at the Secret Garden Café. Both sessions will include an overview of the plan and then time for questions and comments. Refreshments will be provided. Additional sessions will be held in February and March. Information about the plan is available on the town web site at www.occoquan.org.

As always in January, I feel compelled to address the subject of snow. The streets within town boundaries are a hodgepodge of VDOT, town, and HOA property. Consequently, snow removal obligations can be confusing. I therefore encourage everyone to review the town street maintenance map to familiarize themselves with snow removal responsibilities. The map is posted at the Post Office and can be found on the town web site at www.occoquan.org.

I would like to close by thanking former council member Barry Dean for his years of service to the town, and by welcoming our newest council member, Joe McGuire.
